

WASHINGTON TOWNSHIP
ORDINANCE NO. 148

AN ORDINANCE VACATING AND RELOCATING A PORTION
OF TOWNSHIP ROAD #696, LEADING FROM ACKERMANVILLE
TO BANGOR.

The Supervisors of the Township of Washington, Northampton County, Pennsylvania, in a regular meeting assembled, being duly authorized so to do and having in all ways complied with the provisions of Section 1101 et seq. of the Second Class Township Code, as amended, do hereby enact and ordain that a portion of Township Road #696 leading from Ackermanville to Bangor be vacated and relocated, more particularly described as follows:

BEGINNING at a point in Township Road 696 leading from LR48036 to Ackermanville, said point lying distant 1050' southerly from the middle of the aforesaid LR48036; thence southwestwardly 200'; thence southerly 340' /or- to a point in the middle of the said TR 696; thence continuing southeastwardly 170' /or-, to the center of a 16' wide right of way to remain open; thence southerly 360' /or- to a point in the middle of the TR 696; thence southwestwardly 200' /or- to a point along an access driveway to remain open leading to lands now or late owned by J. Ilko; thence continuing southerly 235' /or- to a point; thence southeastwardly 200' /or- to a point in the said TR 696.

The afore-mentioned road to be vacated and relocated for purposes of public convenience to a location more fully described as follows:

BEGINNING at a point in Township Road 696 leading from LR48036 to Ackermanville, said point lying distant 1050' /or- southerly from the middle of the aforesaid LR48036; thence S. 5 degrees 11 minutes E, 58' /or-; thence S. 25 degrees 30 minutes E. 422' to a point at the intersection of portion of road being abandoned with the portion being hereby adopted; thence still S. 25 degrees 30 minutes E., 100' /or- to the center of a 16' wide right of way extended to intersect at this point; thence continuing S.

25 degrees 30 minutes E., 190' to a point; thence S. no degrees 30 minutes W., 300' to a point at the intersection of the portion being abandoned with this portion being adopted; thence still S. no degrees 30 minutes W., 100' to a point; thence S. 13 degrees 30 minutes E., 460' /or- to the intersection of the road being abandoned with the portion herein described. BEING a strip of land having a length of 1630' and a right of way width of 33' measured 16.5' each way from the above described centerline.

The location and width of the vacated and relocated road and the names of the owners of property whereon said roads abut, as required by the Second Class Township Code, as amended, are set forth upon a map or plan made by Rudolph J. Davidge, Registered Engineer, dated February, 1965.
