WASHINGTON TOWNSHIP AMENDED ORDINANCE NO. 162

AN ORDINANCE REGULATING THE SPEED AND STOPPING OF VEHICLES IN WASHINGTON TOWNSHIP, DESIGNATING AND CONFIRMING CERTAIN INTERSECTIONS AND LOCATIONS AS STOP STREETS AND STOP ROADS AND GIVING NOTICE OF THE SAME BY DIRECTING THE ERECTION OF APPROVED TRAFFIC CONTROL SIGNS.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, pursuant to official traffic and engineering studies, and pursuant to the authority granted by law, the Vehicle Code Act of June 17, 1976, P.L. 162, No. 81, Sec. 1, effective July 1, 1977, and amendments thereto, as follows:

SECTION 1 - TITLE.

This Ordinance shall be known as and may be cited as the "Washington Township Vehicle Regulations Code" which shall apply to all vehicles operating on Washington Township roads and streets.

SECTION 2 - ENGINEERING STUDIES.

The regulations of this Ordinance have been fully reviewed, studied, approved and found necessary by engineering and traffic investigation studies by the Township Engineer. All regulations herein are established by authority of the law and the Pennsylvania Vehicle Code. All devices and signs used hereunder shall be of a type and installed in a manner approved by law and said code.

SECTION 3 - STOP STREETS.

The following Township street and road intersections are hereby designated as and shall be stop streets or stop roads which shall be marked with stop signs:

Intersection of Heinsohn Hill - T.R. 663 and Mt. Pleasant Road - T.R. 678. Brodt Road - T.R. 684 and Mt. Pleasant Road - T.R. 678. Johnson Road - T.R. 625 and Mt. Pleasant Road - T.R. 678. Falcone Road - T.R. 684 and Johnson Road - T.R. 625. True Blue Road - T.R. 690 and Johnson Road - T.R. 625. Rasley Hill Road - T.R. 690 and Nagys Hill Road - T.R. 625. La Bar Road - T.R. 625 and Ackermanville Road - T.R. 682. Mack Road - T.R. 625 and Ackermanville Road - T.R. 682. Ackermanville Road - T.R. 680 and Benns Hill Road - T.R. 680. Factoryville Road - T.R. 667 and Ackermanville Road - T.R. 680. Woods Road - T.R. 669 and Factoryville Road - T.R. 667. Hazen Avenue - T.R. 731 and Bangor Junction Road - T.R. 698. Verona Drive - T.R. 701 and Oak Avenue - T.R. 699. Oak Avenue - T.R. 699 and Pine Street - T.R. 674. Pine Street - T.R. 674 and Diamond Street - T.R. 671 - West. Pine Street - T.R. 674 and Diamond Street - T.R. 671 - East. Old Pen Argyl Road - T.R. 671 and American Bangor Road - T.R. 681. Middletown Road - T.R. 670 and American Bangor Road - T.R. 681. Mt. Pleasant Road - T.R. 678 and Palmer Road - T.R. 678. Palmer Road - T.R. 678 and Mt. Pleasant Road - T.R. 678. Palmer Road - T.R. 678 and Springfield Drive - T.R. 677. Farview Avenue - T.R. 721 and Hillside Drive - T.R. 720. Flicksville Mt. Pleasant Road - T.R. 663 and Flicksville Mt. Pleasant Road - T.R. 678. Bunny Trail - T.R. 679 and Locke Heights Road - T.R. 706.

Rutt Road - T.R. 679 and Locke Heights Road - T.R. 706.

Richmond Road - T.R. 663 and Cedar Road - T.R. 706.

Sleepy Hollow Lane - T.R. 723 and Plush Street - T.R. 722.

Flicksville Road - T.R. 710 and Flicksville Road - T.R. 708 - East Flicksville Road - T.R. 708 and Flicksville Road - T.R. 710 - Sout

Hillside Drive - T.R. 720 and Flicksville Road - T.R. 710.

Treeline Drive (North) and Green Meadow Lane.

Treeline Drive (South) and Green Meadow Lane.

SECTION 4 - SPEED LIMITATIONS.

The following Township roads or streets shall be properly marked with speed limit signs of thirty-five (35) miles per hour as follows:

Section of

Ackermanville Road - T.R. 682 extending from Pa. L.R. 191 to Factoryville Road - T.R. 667.

Flicksville Road - T.R. 710 extending from Pa. L.R. 191 to Pa. L.R. 165.

Locke Heights Road - T.R. 706 extending from Pa. L.R. 48033 to East Bangor Borough line.

Molasses Road - T.R. 696 extending from Pa. L.R. 191 northerly to Pa. L.R. 48036.

SECTION 5 - VIOLATIONS AND PENALTIES.

Violation of any of the signs enumerated in Sections 3 and 4 above shall be prosecuted under the appropriate provisions of the Pennsylvania Vehicle Code as amended.

SECTION 6 - SEVERABILITY.

The provisions of this Ordinance, and all parts thereof are severable, and if any part of this Ordinance and chapter or clause or sentence hereof is for any reason found to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair the remaining provisions of this Ordinance or any part thereof. It is hereby declared to be the intent of the Board of Supervisors of Washington Township that this Ordinance would have been adopted had such unconstitutional or invalid section not been included in this Ordinance.

THIS ORDINANCE shall be effective five (5) days after enactment thereof.
