

ORDINANCE NO. 184

AN ORDINANCE PROVIDING FOR THE REGULATION AND CONTROL OF THE SUBDIVISION OF LOTS AND THE DEVELOPMENT OF LAND; THE APPROVAL OF PLOTS, OR REPLOTS OF LAND LAID OUT IN BUILDING LOTS: STANDARDS FOR THE DESIGN OF STREETS, LOTS, EASEMENTS, BLOCKS AND OTHER IMPROVEMENTS; CERTAIN MINIMUM IMPROVEMENTS AND CONSTRUCTION. STANDARDS ON ALL STREETS AND REOUIRED DEDICATIONS: ADMINISTRATION OF THIS ORDINANCE BY THE WASHINGTON TOWNSHIP PLANNING COMMISSION AND THE WASHINGTON TOWNSHIP BOARD · OF SUPERVISORS; AND PENALTIES FOR THE VIOLATION OF THIS ORDINANCE.

BE IT ENACTED AND ORDAINED and same is hereby ordained and enacted by the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, at a public meeting duly convened as follows:

<u>Section 1</u>: The Subdivision and Land Development Ordinance of Washington Township heretofore enacted is hereby amended in its entirety.

<u>Section 2</u>: The attached Comprehensive Redraft and Amendment to the Subdivision and Land Development Ordinance of Washington Township is hereby enacted.

<u>Section 3</u>: All provisions of prior Ordinances of the Township of Washington, or parts thereof, inconsistent herewith, are hereby amended and superseded.

Section 4: Should any provision of the attached Comprehensive Redraft and Amendment to the Subdivision and Land Development Ordinance of Washington Township, which shall be known as Ordinance No. 184, be declared to be unenforceable or illegal, the remaining portions thereof shall remain in full force and effect.

Section 5: This Ordinance No. 184 shall be placed into effect immediately upon enactment, and a certified copy hereof shall be forwarded to the Joint Planning Commission of Lehigh-Northampton Counties in compliance with the provisions of the Pennsylvania Municipalities Planning Code, as amended.
