ORDINANCE NO. 190

AN ORDINANCE AMENDING ORDINANCES NO. 162 AND NO. 182 OF THE TOWNSHIP OF WASHINGTON, REGULATING THE SPEED AND STOPPING OF VEHICLES AND DESIGNATING AND CONFIRMING CERTAIN INTERSECTIONS AND LOCATIONS AS STOP STREETS AND STOP ROADS AND GIVING NOTICE OF THE SAME BY DIRECTING THE ERECTION OF APPROVED TRAFFIC CONTROL SIGNS.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Washington Township, Northampton County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, pursuant to official traffic and engineering studies, and pursuant to the authority granted by law, the Vehicle Code Act of June 17, 1976, P.L. 162, No. 81, Sec. 1, effective July 1, 1977, and amendments thereto, as follows:

SECTION 1.

Section 4 of Ordinance No. 162 shall be amended upon enactment hereof to read as follows:

SECTION 4 - SPEED LIMITATIONS

The following Township roads or streets shall be properly marked with speed limit signs of thirty-five (35) miles per hour, as follows:

Ackermanville Road - T. R. 662 extending from Pa. L.R. 191 to Factoryville Road - T. R. 667, both ways.

Flicksville Road - T. R. 710 extending from Pa. L. R. 191 to Pa. L. R. 165, both ways.

Locke Heights Road - T. R. 706 extending from Pa. L. R. 48033 to East Bangor Borough line.

Bangor Junction Road from Pa. Route 0512 to S.R. 1020, both ways.

Bunny Trail from Locke Heights Road to the Township Line, both ways.

Johnson Road from True Blue Road to Mt. Pleasant Road, both ways.

Locke Heights Road from 1018 to the Township Line, both ways.

Mount Pleasant Road from South Main Street to the Township Line, both ways.

O. W. Road from Pennsylvania Route 191 to State Route 1016 (Delabole Road), both ways.

Palmer Road from Mount Pleasant Road (Township Road No. 663) to Springfield Drive, both ways.

Rutt Road from the Washington Township/Bangor Borough Boundary Line to Locke Heights Road, both ways.

Springfield Drive from South Main Street to S.R. 1018, both ways.

SECTION 4.A

The following Township roads or streets shall be properly marked with speed limit signs of thirty (30) miles per hour, as follows:

Old Pen Argyl Road (Township Road No. 668), along its entire length, both ways.

SECTION 2.

All other provisions of Ordinance No. 162 enacted on December 14, 1982, shall remain in full force and effect. Ordinance No. 182, enacted on February 9, 1994, is amended in its entirety.

SECTION 3 - SEVERABILITY.

The provisions of this Ordinance, and all parts thereof are severable, and if any part of this Ordinance and chapter or clause or sentence hereof is for any reason found to be invalid or

unconstitutional, such invalidity or unconstitutionality shall not affect or impair the remaining provisions of this Ordinance or any part thereof. It is hereby declared to be the intent of the Board of Supervisors of Washington Township that this Ordinance would have been adopted had such unconstitutional or invalid section not been included in this Ordinance.

SECTION 4.

This Ordinance shall be effective five (5) days after enactment hereof.
