Engineer Zak Karasek, Ott Consulting, presented the Review Letter as follows:

The existing 6-acre site for this project is located at the intersection of Palmer Rd (TR 662, Collector) and Springfield Dr (TR 677, Collector) within the Agricultural (A) Zoning District. The project includes existing tax map parcel E10-8-15.

The site is currently wooded with an existing gravel driveway. This plan proposes to subdivide the parcel into 2 single-family detached residential building lots (1.8 acres for Lot 1 and 4.2 acres for Lot 2). Access for Lot 1 is shown via a proposed driveway from Palmer Rd, and access for Lot 2 is shown via a proposed extension of the existing driveway from Palmer Rd. Sewage disposal and water service are proposed as on-lot.
